Minutes of 101st meeting of the Approval Committee constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005 held on 13.04.2018 at 11.00 AM in the Chamber of Development Commissioner, Falta Special Economic Zone 4th Floor, 2nd MSO Building, Nizam Palace, 234/4., AJC Bose Road, Kolkata-700 020 regarding Falta SEZ, Manikanchan SEZ, Wipro IT/ITES SEZ & IT/ITES SEZ units in Candor Kolkata One Hi-tech Structures (P) Ltd., M/s. M.L. Dalmiya & Company Ltd., TCS Ltd. and DLF IT/ITES SEZ, Kolkata. List of participants is enclosed at Annexure-I.

The Zonal Development Commissioner welcomed the Members of the Committee. The Committee was informed that no reference against the decisions of the Unit Approval Committee held on 22.03.2018 was received from any member of the Committee or trade and therefore, minutes of the meeting was taken as confirmed in the meeting.

Agenda Item No.1: Request for inclusion of export product in the existing Letter of Permission(LOP) No. FEPZ/LIC/A-37/2000/10835 dated 18.01.2000 of M/s. A.P. Fashions (P) Limited.

As per the direction of the 100th UAC meeting held on 22.03.2018, the representative of the unit appeared before the Committee and clarified that they intend to include the semi finished Ladies Pant of Jeans for doing embroidery at their unit and no outside job work will be required.

After deliberation the committee approved for inclusion of semi finished Ladies Pant of Jeans for doing embroidery under ITC (HS) Code No.62046200, subject to the condition that no job work will be allowed in DTA (This was confirmed and agreed by the representative) in the existing Letter of Permission (LOP) No. FEPZ/LIC/A-37/2000/10835 dated 18.01.2000, in terms of provision of 1st Proviso in Rule 19(2) of SEZ Rules, 2006.

Agenda Item No.2: Representation as against the Order of the Adjudicating authority & DC, Falta SEZ dated 07-04-2016 for granting extension of validity of LOP of M/s. Alps Overseas Private Limited having LOP No. FEPZ/LIC/A-24/1997/1001 dated 09.05.1997.

As per the direction of the 99th UAC meeting held on 27.02.2018, DOC vide their letter no.K.43016(15)/1/2018-SEZ dated 07.02.2018 requested DC for taking necessary action. The matter related to Adjudicating Authority order dated 07.04.2016 issued by the Development Commissioner, FSEZ regarding extension of validity of cancelled LOP was discussed.

Shir Ashok Kumar Choudhury, Director of the said unit appeared and deliberated their request before the committee.

The committee noted that the LOP has already been cancelled due to nonpayment of rental dues vide Order in Original dated 7.4.2016. The case was discussed in the meeting as the direction given by the DOC 'for taking necessary action'.

With reference to the directives of 99th UAC held on 27/2/2018, the unit has cleared their rental dues for Rs.41,63,385/- by two Demand drafts dated 28/12/2017 and balance outstanding of Rs.1,03,521/- still remain which will pay in due course as confirmed by the unit with a request to re-activate the LOP immediately vide their letter dated 19/3/2018.

After deliberation the committee decided that the representation of M/s. Alps Overseas Private Limited may be forwarded to the DOC, New Delhi with a factual position/present status of the case with reference to the direction of DOC, New Delhi since the UAC does not have authority to consider their prayer for renewal/restoration of cancelled LOP.

Agenda Item No.3: Request of M/s. Robinson International Pvt. Limited for renewal of validity of Letter of Permission(No. FEPZ/LIC/R-25/1997/5596 dated 27/2/1997 for a further period of one year beyond 31.03.2018.

The request of M/s. **M/s. Robinson International Pvt. Limited** for renewal of LOP for further period of one year beyond 31.3.2018 was discussed in the meeting.

After deliberation the committee approved the validity of LOP for a period of one year (including six months extended period) upto 31.03.2019 with the same terms and conditions of existing LOP i.e. LOP which was extended last time in the year 2017 under the provision of Rule 19(6) of SEZ Rules, 2006.

Agenda Item No.4: Request of M/s. Jai Bharat Plastics (Trading) for extension of validity of LOA No. FSEZ/LIC/J-22/Trading/2005/6420 dated 04.01.2006.

The request for renewal of LOA of M/s. Jai Bharat Plastics (Trading) for a further period of three months for clearing the stock was discussed in the meeting.

After deliberation the Committee approved validity of LOA for a further period of three months w.e.f the date of issue of LOA only for clearing the existing stock in the factory & No further import/procurement/exports will be allowed.

Agenda Item No.5: Matter related to setting up a Sweet & Ready to Eat Vegetarian and Non Vegetarian food and tea and Beverages Counter at M/s. Candor Kolkata One IT/ITES SEZ by M/s. ALP Retail Pvt. Limited.

The proposal of M/s. ALP Retail Private Limited for setting up of a Sweet & Ready to Eat Vegetarian, Non Vegetarian food, tea and Beverages Service Counter for employees M/s. Candor Kolkata One IT/ITES SEZ located at New Town, Rajarhat, Kolkata was discussed in the

Committee . The representative of M/s. ALP Retail Private Limited and the Developer of SEZ were appeared before the committee and deliberated their request.

After deliberation the committee approved for setting up of a Sweet & Ready to Eat Vegetarian, Non Vegetarian food, tea and Beverages Service Counter for employees of M/s. **Candor Kolkata One IT/ITES SEZ** and no exemption will be allowed.

Agenda Item No.6 Ratification of Minutes of 98th UAC Meeting held on 31/1/2018 regarding changes in typographical errors in allotment of vacant land adjacent to existing units and shed.

The matter related to changes in the **Minutes** of 98th UAC Meeting held on 31/1/2018, regarding allotted area of vacant open land from 900 Sq.mtr to 700 Sq.mtr to M/s. Sonodyne Technologies Pvt. Limited, from 1000 sq.mtr to 1530 sq.mtr. to M/s. Kkalpana Industries (India) Limited and allotted vacant Shed measuring of 300 Sq.Mtr to M/s. Adityathrav Textiles Pvt. Ltd. in **SDF (E) building 1st floor** was discussed.

After deliberation the committee ratified the same.

Agenda Item No.1: Request for extension of validity of LOA of M/s. One Plus Fashion Pvt. Limited

The matter related to extension of validity of LOA for a further period upto 31st October, 2018 of M/s. One Plus Fashion Pvt. Limited, located at Falta SEZ was discussed at length in the meeting.

After deliberation the committee approved the extension of validity of LOA of M/s. One Plus Fashion Pvt. Limited upto 31st October, 2018 on the basis of the firm's Undertaking dated 12/4/2018 that an amount of Rs.4,00,000/- will be paid out of total outstanding of Rs.8,39,000/- as pending Lease rent and balance amount to be cleared on installment basis within a period of 6 months with the same terms and conditions as stipulated in the original LOP. This decision will be executed only after the payment of Rs.4,00,000/- as aforesaid is made.
