Minutes of 95th meeting of the Approval Committee constituted in terms of Section 13 of Sub Section 1 of the Special Economic Zone Act, 2005, held on 08.11.2017 at 5.30 P.M. in the Chamber of Development Commissioner, Falta Special Economic Zone, 4th floor, 2nd MSO Building, Nizam Palace, 234/4, A J C Bose Road, Kolkata - 700020 regarding Falta SEZ, Manikanchan SEZ, Wipro IT/ITES SEZ units in Candor Kolkata One Hitech Structures (P) Ltd., M/s. M L Dalmiya & Company Ltd. TCS Ltd. and DLF IT/ITES SEZ, Kolkata.

The 95th meeting of Unit Approval Committee was held on 08.11.2017, the UAC Members considered the proposals received from the units in Falta SEZ, IT/ITES units in Candor Kolkata One Hitech Structures (P) Ltd. and DLF IT/ITES SEZ, Kolkata. List of participants is enclosed at Annexure-I.

The Development Commissioner welcomed the Members of the Committee.

The Committee was informed that no reference against the decisions of the Approval Committee held on 10.10.2017 was received from any member of the Committee or trade except the case of ratification of M/s. Eastern Silk Industries and therefore, minutes of the meeting held on 10.10.2017 was taken as confirmed and ratified in the meeting.

Agenda Item No.1. Ratification of the date of LOP M/s. Eastern Silk Industries (Trading) for extension of LOA for a period of five(05) years.

The date of extension of LOP of M/s. Eastern Silk Industries (Trading) holding LOP No. FEPZ/LIC/E-11/98/4889 dated 14.10.1998 which has been done by typographic mistake has been duly ratified by the Committee and the date should be 25.3.2014 instead of 26.3.2014.

Agenda Item No.2. - Request for renewal of LOA of M/s. S.S. Engineering Company beyond 19.12.2015.

The request for renewal of LOA of M/s. S. S. Engineering Company beyond 19.12.2015 as applied by the firm dated 1.11.2017 was discussed at length. The Committee decided to defer for the next UAC Meeting. The applicant should submit complete future Road map, in detail for exports. The committee noted that there is an outstanding rental dues and they should pay it immediately for further consideration of request.



Agenda Item No.3. - Request for renewal of LOA of M/s. Linc Pen and Plastics Ltd. as a Trading Unit for a period of 5 years beyond 30.9.2017.

The request for renewal of LOA of M/s. Linc Pen and Plastics Ltd. vide on-line application dated 06.06.2017 was discussed and after deliberation the Committee recommended for extension of LOA for a further period of 3 months as the performance of export is not satisfactory. The Committee also directed the firm to submit future plan of export and the same may be placed in the next UAC meeting for taking further action.

Agenda Item No.4. - Request of M/s. Cognizant Technology Solution India Pvt. Ltd. for renewal of validity of LOA for a further period of 5 years.

The request for renewal of LOA of M/s.Cognizant Technology Solution India Pvt. Ltd., located at Candor Kolkata One Hi- Tech Structures Pvt. Ltd., IT/ITES SEZ, New Town, Rajarhat, Kolkata – 700156 was discussed and after deliberation the Committee has approved for renewal of validity of LOP for further period of 5 years beyond 8/11/2017.

Agenda Item No.5. - Request for approval of “KIOSK” Services in the SEZ under Provision of Rule 11(5) of SEZ Rules, 2006 at M/s. DLF Ltd., IT/ITES SEZ, New Town, Rajarhat, Kolkata.

The request of M/s. DLF Ltd., IT/ITES SEZ, New Town, Rajarhat, Kolkata vide letter dated 6/10/2017 & 26/9/2017, as a Developer of the said SEZ to set up a “KIOSK” inside the SEZ by M/s. M.P. Health & Lifestyle as reflected in the Agenda was discussed and after deliberation the Committee approved the same subject to the condition that they will not take any duty exemption/benefit(the same has been mentioned in their request) under SEZ Act & Rules and the services should be utilized only by their SEZ employees.

Agenda Item No.6. - Request for approval of “KIOSK” Services in the SEZ under Provision of Rule 11(5) of SEZ Rules, 2006 at M/s. DLF Ltd., IT/ITES SEZ, New Town, Rajarhat, Kolkata.

The request of M/s. DLF Ltd., IT/ITES SEZ, New Town, Rajarhat, Kolkata vide letter dated 24/10/2017 & 23/10/2017, as a Developer of the said SEZ to set up a “KIOSK” inside the SEZ by M/s. Guha Roy Food Joint & Hotels (P) Limited, as reflected in the Agenda was discussed and after deliberation the Committee approved the same subject to the condition that they will not take any duty exemption/benefit under SEZ Act & Rules (the same has been mentioned in their request) and the services should be utilized only by their SEZ employees.

1.	Transworld Business Corporation (Trading)	2 nd Block-5 th Year-2016-17	The Committee noted that for negative NFE cumulatively from the FY 2012-13 to 2014-15 as reflected in the monitoring sheet. Therefore it was decided to examine the APR as well as Customs Data thoroughly by the CA personnel and to submit a report thereon.
2.	M/s. Silk Industries Limited (Trading)	3 rd Block- 2008-09 to 2012-13 4 th Block- 1 st Year 2016-17	The Committee noted that the APR figures and Customs figure could not be done as bifurcation of figures between trading unit and manufacturing unit. Accordingly it was decided they may be requested to furnish the separate APR for Manufacturing unit as well as trading unit.
3.	M/s. Line Pen Plastics Limited (Trading)	2 nd Block- 2 nd Year- 2016-17	The Committee noted and it was decided that the unit may be requested to clarify the amount of pending realization to the tune of Rs.0.17 Crores. As against physical export of Rs.0.49 Crores.

There being no other points for discussion, the Meeting ended with a vote of thanks to and from the Chair.
